TACHI-S received a recognition certificate for "ESG Practices" given by "Sistema Fiep" in Brazil

TACHI-S Brasil Industria de Assentos Automotivos Ltda. (President: Luis Soria, hereinafter TSB), which is a subsidiary in Brazil of TACHI-S Co., Ltd. (President, CEO&COO: Yuichiro Yamamoto, Headquarter: Ome, Tokyo, hereinafter TACHI-S) received a recognition certificate for "ESG Practices" given by "Sistema Fiep".

TSB's plant in São Jose dos Pinhais was invited to participate in Project "ESG em Foco 2024" by Fiep, "Federação das Indústrias do Estado do Paraná", an Entity supported by Federal and State government, for the purpose of evaluating ESG practices of the companies operating in Paraná State.

The special commission tasked with this project took 4 months, diving into TSB's internal process, procedures and projects using Fiep methodology that assesses 29 requirements in the field of Environmental, Social and Governance.

The objective of the project is to bring ESG practices of the companies operating in the state of Paraná in line with those of global companies with the aim of upgrading ESG activities of the companies in the state. TSB's overall score was 92.8%. According to Sistema Fiep's feedback, there are approximately 400 certified companies out of 1.5 million companies in Paraná State, and TSB was one of the few companies that performed well in the state's ESG assessment.

This accreditation is a great recognition for TSB. TSB is committed to being a sustainable and profitable company, contributing to the community, and minimizing its environmental impact. TSB will also strive to meet the expectations of our stakeholders and continue to make a positive contribution to society through ESG activities, while implementing the Tachi-S Group's vision of "To live in harmony with individuals and society and to put smiles on people's faces by continuously creating living spaces of comfort and enrichment."
